OLD BUSINESS:

<u>Bio-Fuel Update:</u> An article by the US Department of Energy "Clean Cities" program, published in Feb 2011 states that biodiesel can be used on vehicles manufactured after 1993. It also states that Original Equipment Manufacturers don't recommend using biodiesel blends above B5 in onhighway vehicles manufactured in 2007 and later. Our current mix of diesel vehicles ranges from 1969 (road grader) to 2001 (pickup). Our newest diesel is the crack sealer which is 2006. Due to the age of the vehicle fleet, it is not currently feasible to integrate biofuel into use without maintaining multiple types of diesel fuel storage. Mike will create a resolution stating this and submit it at the September 17th meeting.

<u>2018 Budget Stats Review: 1 January – July 31:</u> Mike reviewed the status of the budget with the commissioners. Overall, the budget is on target.
